# Commentary

During April, the NAV return of the Lazard Global Total Return and Income Fund (the "Fund") was 0.1%, underperforming the MSCI All Country World Index (MSCI ACWI)<sup>4</sup> return of 0.9%. For the year-to-date, the NAV return of -1.3% is behind the MSCI ACWI Index return of -0.4%. Over the last three years, the annualized NAV return of 6.9% is below the 10.3% return on the Fund's benchmark index (MSCI ACWI and MSCI World Index linked)<sup>5</sup>.

Global equity markets recorded a modest gain in April, as risk appetites waxed and waned amid growing uncertainty over US tariffs. The announcement that the US was implementing a minimum tariff of at least 10% on imports, with an even higher tax rate on goods from China, led to a steep sell-off in the US stock market, which worsened in subsequent days after China announced its own set of tariffs. The US subsequently announced a 90-day pause in the implementation of these tariffs, sparking a strong relief rally. The pause, however, did not apply to China, leaving the market on edge until optimism grew about the two sides' willingness to negotiate. Against this backdrop, equity markets in both the developed and developing worlds rose in April, with the latter outperforming the former. In the US, stocks declined for the third consecutive month, as strong earnings results were offset by tariff concerns. Stocks in Europe benefited from optimism about the prospect of interest rate cuts. Japanese equities outperformed, despite fears that a global trade war would adversely impact the country's export-reliant economy. In China, stocks declined, amid concerns that a trade war between the US and China would hurt demand for Chinese goods. In April, the Fund benefitted from security selection in the industrials sector and within the US and from a lower-than-benchmark exposure to the energy sector. Conversely, security selection within the financials, health care and information technology sectors detracted from relative performance.

The smaller, short duration emerging market currency and debt portion of the Fund continued its year-to-date recovery in April following a period of weaker performance at the latter part of 2024.



# Investment Objective

The Fund's investment objective is total return, consisting of capital appreciation and current income. The Fund's net assets are invested in a portfolio of approximately 60 to 80 US and non-US equity securities, including American Depository Receipts, generally of companies with market capitalizations greater than \$2 billion, and may include investments in emerging markets. The Fund also invests in emerging market currencies (primarily by entry into forward currency contracts), or instruments whose value is derived from the performance of an underlying emerging market currency, and also may invest in debt obligations, including government, government agency and corporate obligations and structured notes denominated in emerging market currencies.







#### Risks

Investment and Market Risk. An investment in the Fund's Common Stock is subject to investment risk, including the possible loss of the entire principal amount invested. An investment in Common Stock represents an indirect investment in the Fund's portfolio investments. Their value, like other market investments, may move up or down, sometimes rapidly and unpredictably.

The Fund's Common Stock, at any point in time, may be worth less than the amount originally invested, even after taking into account the reinvestment of Fund dividends and distributions. The Fund's investment strategy includes purchasing investments that have embedded financial leverage, such as forward currency contracts, which magnifies the risk that you may lose money.

Leverage Risk. Using leverage is a speculative investment technique and involves certain risks. These include higher volatility of net asset value, the likelihood of more volatility in the market value of Common Stock and the possibility either that the Fund's return will fall if the interest rate on any borrowings rises, or that income will fluctuate because the interest rate of borrowings varies. If the market value of the Fund's portfolio declines, the leverage will result in a greater decrease in net asset value than if the Fund were not leveraged. Such greater net asset value decrease also will tend to cause a greater decline in the market price for Common Stock.

Non-U.S. and Emerging Markets Investments Risk. The Fund may invest in securities of non-US issuers operating in developed countries. These investments involve special risks, including the following: less publicly available information about non-U.S. issuers or markets because of less rigorous disclosure or accounting standards or regulatory practices; many non-US markets are smaller, less liquid and more volatile; the economies of non-U.S. countries may grow at slower rates than expected or may experience a downturn or recession; and the impact of economic, political, social or diplomatic events.

The Fund may also invest in emerging markets securities. Particular risks include: smaller market capitalization of securities markets; significant price volatility; restrictions on foreign investment; and possible seizure of a company's assets. In addition, foreign investors may be required to register the proceeds of sales. Future economic or political crises could lead to price controls, forced mergers, expropriation or confiscatory taxation, seizure, nationalization, or creation of government monopolies, all of which may affect currencies adversely.

Investing in sovereign debt securities will expose the Fund to the direct or indirect consequences of political, social or economic changes in the emerging market countries that issue the securities. Many of these countries are also characterized by political uncertainty or instability. The ability and willingness of sovereign obligors in emerging market countries or the governmental authorities that control repayment of their debt to pay principal and interest on such debt when due may depend on general economic and political conditions within the relevant country. Countries in which the Fund intends to invest have historically experienced, and may continue to experience, high rates of inflation, high interest rates, exchange rate fluctuations, trade difficulties and extreme poverty and unemployment.

The market values of corporate debt securities are sensitive to individual corporate developments and changes in economic conditions. Emerging market issuers may be highly leveraged and may not have more traditional methods of financing available to them. Therefore, their ability to service their debt obligations during an economic downturn or during sustained periods of rising interest rates may be impaired, resulting in a higher risk of default.

<u>Currency Risks</u>. An investment in Common Stock, as measured in US dollars, may change significantly when the values of the emerging market local currencies change relative to the US dollar, thereby subjecting investors to currency risks. The currencies of emerging market countries may experience significant declines against the US dollar, and significant devaluation may occur subsequent to investments in these currencies by the Fund. Other risks include the dependence on the Investment Manager's ability to predict movements in exchange rates and imperfect correlations between movements in exchange rates. The Fund may use currency hedging transactions which might result in a poorer overall performance for the Fund than if the Fund had not engaged in any hedging transactions.

Currency Investments could be adversely affected by delays in, or a refusal to grant, repatriation of funds or conversion of emerging market currencies. Forward currency contracts are highly volatile, and a relatively small price movement in a forward currency contract may result in substantial losses to the Fund.

<u>Forward Currency Contract</u>. A contract for the purchase or sale from a counterparty of a specified currency at a specified future date. Such contracts may involve the purchase or sale of the local currency against the U.S. dollar or may involve the local currency and another developed market base currency.

<u>Net Asset Value Per Share</u>. An expression for net asset value that represents a fund's (mutual, exchange-traded, and closed-end) or a company's value per share. The Fund's Net Asset Value Per Share is calculated by dividing its total net asset value by the number of shares outstanding.

<u>Total Leveraged Assets</u>. The Fund's Net Assets, increased by financial leverage employed by the Fund, which is (1) the amount the Fund has drawn from its available line of credit and (2) the notional value of forward currency contracts the Fund enters into.

Leveraged Percentage. The Fund's financial leverage as a percentage of the total of its Total Leveraged Assets.

- 1 Past performance does not guarantee future results. The NAV results are calculated using the Fund's Net Asset Value per share and assumes reinvestment of all distributions. NAV performance data shown reflects the deduction of the Fund's operating expenses, which include (but are not limited to): management fees, professional services, and custodian and administration fees. The Fund's inception date was April 28, 2004.
- 2 Data is based on the Fund's holdings as of April 30, 2025, which are subject to change in the future.
- 3 The Distribution Rate is calculated by dividing the annualized monthly distribution by the share price shown above. The monthly distribution is established by the Fund's Board of Directors at the beginning of each year pursuant to a managed distribution policy. Under the policy, in an effort to seek to maintain a stable monthly distribution to shareholders, the Fund makes regular monthly distributions at a fixed rate per share. The Policy may have the effect of causing anyone (or more) of such distributions to be made from the Fund's assets as a return of capital if Fund income and realized capital gains were less than the amount(s) distributed. In addition, in order to make such distributions, the Fund might also have to sell a portion of its investment portfolio at a time when independent investment judgment might not dictate such action. Based on current information, 63.3% of the year-to-date cumulative distributions are estimated to be comprised of return of capital. It is important to note that an investment in shares of the Fund is not comparable to a fixed-income investment such as a bond or a note.
