Composite Description

The composite returns represent the total returns of all fully discretionary portfolios with a Global Thematic Equity investment mandate. Lazard’s Global Thematic Equity strategy is a long-only, style-agnostic investment discipline focusing on long-term investment returns with low absolute risk. The portfolio is based on a series of 8-12 investment themes, not the benchmark. Tracking error is therefore not a managed factor. The portfolio comprises 80-120 securities of companies represented in the MSCI World Index and the emerging markets, with a market capitalization of generally \$1 billion or greater.

Calculation of Performance Returns

The composite and benchmark returns are reported net of foreign withholding taxes on dividends, interest and capital gains. The composite returns presented represent past performance and is not a reliable indicator of future results, which may vary.

Fee Schedule

Lazard’s standard fee schedule for Global Thematic Equity accounts is 0.75% on the first \$100 million and 0.65% on the balance. (This fee schedule may be presented in non-U.S. local currency equivalents based on prevailing exchange rates.) Composite net-of-fees returns are calculated by reducing monthly composite returns by the 12th root of the stated strategy fee’s highest tier.

Benchmark Information

The MSCI ACW Index (ACW) is a free float-adjusted market capitalization index that is designed to measure equity market performance in the global developed and emerging markets. The Index is compiled by Morgan Stanley Capital International.
