Composite Description

The composite returns represent the total returns of all fully discretionary taxable and tax-exempt portfolios with a UK Equity Alpha investment mandate and a minimum of £3 million in assets under management from the first full month or the end of the month in which the account is fully invested. Lazard's UK Equity Alpha strategy aims to achieve long-term capital growth from investment in a concentrated portfolio of between 40 and 50 carefully selected UK equities. The portfolio is based on the belief that financial productivity measures how effectively a company is putting its shareholders' capital to work - and ultimately this drives valuation.
