Composite Description

The composite returns represent the total returns of all fully discretionary portfolios with an Australian Equity Income investment mandate. The Lazard Australian Equity Income strategy is designed to provide regular, tax effective income that grows over time. It sources that income by investing in Australian companies with sustainable dividends. The strategy has a dual objective of providing income and capital growth. Depending on the breadth and depth of sustainable income opportunities, it can hold up to 10% in cash. The strategy should provide lower volatility relative to a fully invested Australian equity portfolio.

Calculation of Performance Returns

Policies for valuing investments, calculating performance, and preparing GIPS reports are available upon request. The composite returns are reported net of foreign withholding taxes on dividends, interest and capital gains. The composite returns presented represent past performance and is not a reliable indicator of future results, which may vary. Fee Schedule

Lazard's standard fee schedule for Australian Equity Income accounts is 0.48% on the first \$A100M of assets, 0.37% on the next \$A100M and 0.32% on the balance. (This fee schedule may be presented in non-Australian local currency equivalents based on prevailing exchange rates.) Composite net-of-fees returns are calculated by reducing monthly composite returns by the 12th root of the stated strategy fee's highest tier.
