A Form of Proxy for use in connection with the General Meeting is enclosed. To be valid for use at the General Meeting, the Form of Proxy must be completed, signed and returned in accordance with the instructions printed thereon so as to be received by the Company’s Registrar, Computershare Investor Services PLC, at The Pavilions, Bridgewater Road, Bristol BS99 6ZY or submitted online at eproxyappointment.com as soon as possible, but in any event not later than 10.00 a.m. on 11 August 2026.

Notice of General Meeting

1. Introduction

The Company operates a discount control mechanism (“**DCM**”) supporting the sales, marketing and shareholder engagement functions. Under the DCM the Company issues and purchases Ordinary Shares with the aim, within normal market conditions, of maintaining the Company’s share price within a band of plus or minus 2 per cent. relative to the Company’s net asset value (“**NAV**”) per share. The DCM has successfully operated since 2014, with the Company’s Ordinary Shares having not traded at a material discount to their underlying NAV since its inception. The Board believes that the operation of the DCM provides liquidity and accretive benefits such as reducing discount volatility. This is achieved by both issuing and, more recently, buying back Ordinary Shares under the DCM and the Company believes this to be in the best interests of Shareholders, both current and prospective.

The Board believes that the early renewal of the Company’s buyback authority is necessary to ensure the continuing successful operation of the DCM. At the Company’s last general meeting held on 27 February 2026 (the “**February GM**”), Shareholders granted the Company the authority to buy back up to 4,542,323 Ordinary Shares (the “**Existing Authority**”). In the period from the the February GM to 15 July 2026 (the latest practicable date prior to the publication of this document), the Company has bought back 3,033,500 Ordinary Shares, representing 67 per cent. of the Existing Authority, and the Existing Authority may be fully utilised prior to the next annual general meeting which is expected to be held on 21 October 2026 (the “**2026 AGM**”). All shares will bought back at a discount to NAV and therefore the Board's intention is that all buy backs will be accretive to NAV per share.

The Existing Authority of the Company to make market purchases of up to 14.99 per cent. of the issued Ordinary Shares of the Company expires at the conclusion of the 2026 AGM. The Resolution, as set out in the Notice of the General Meeting, will replace the Existing Authority and will expire at the conclusion of the 2026 AGM. The price paid for shares will not be less than the nominal value of 5 pence per share and the maximum price shall be the higher of (i) 5 per cent. above the average middle market quotations for an Ordinary Share as derived from the London Stock Exchange Daily Official List for the 5 business days immediately preceding the day on which the purchase is made; and (ii) the higher of the price of the last independent trade of an Ordinary Share and the highest current independent bid for such a share on the London Stock Exchange at the time the purchase is carried out. Any shares purchased under the authority will be held in Treasury and can be reissued when the Company's share price is at a premium to its NAV per share as required.

Accordingly, in order to provide the Company with as much flexibility as possible to continue to operate the DCM effectively, the Company proposes to put forward a special resolution at the General Meeting to authorise the Company to continue to make market purchases of its Ordinary Shares in accordance with certain conditions (the “**Proposal**”).

The purpose of this document is therefore to convene the General Meeting at which Shareholders will be asked to vote in favour of the Proposal. The General Meeting will be held at 10.00 a.m. on 13 August 2026 at the offices of Juniper Partners Limited, 28 Walker Street, Edinburgh EH3 7HR.

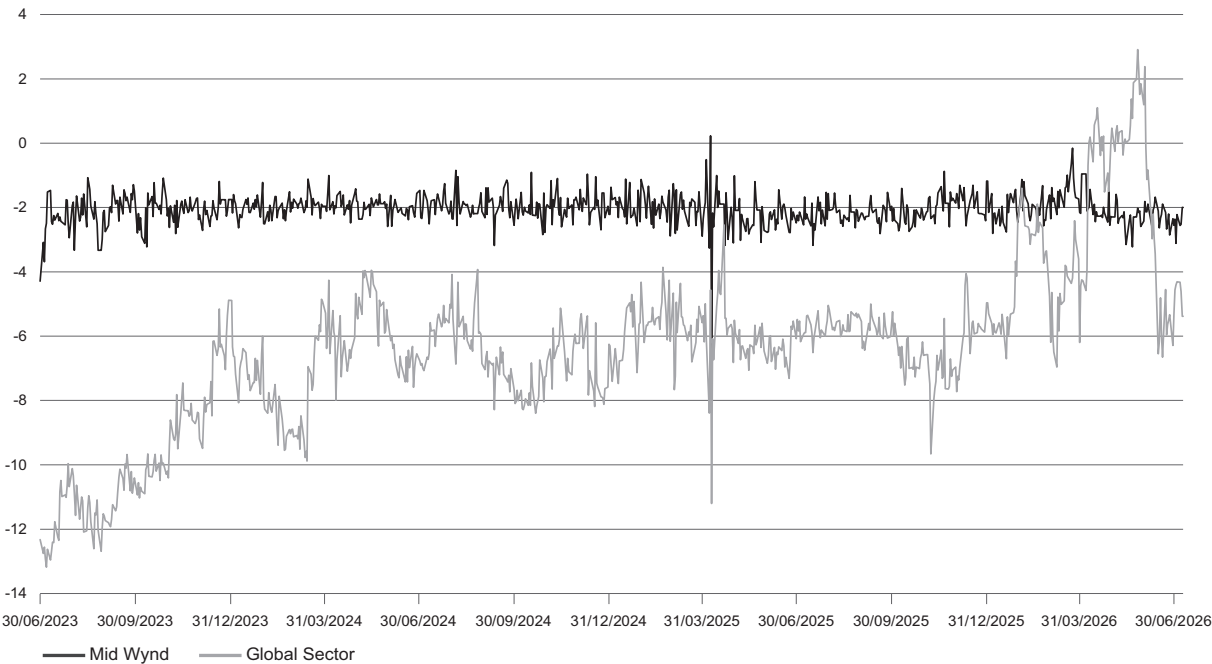
For the reasons set out below, the Directors believe that the Proposal is in the best interests of the Company and its Shareholders as a whole. Shareholders are encouraged by the Board to vote in favour of the Resolution to facilitate the continued smooth operation of the DCM.

2. Reasons for the early renewal of the Company’s share buyback authority

The Company’s remaining authority granted at the February GM will permit the Company to buy back a further 1,508,823 Ordinary Shares (representing approximately 6 per cent. of the Company’s issued share capital (excluding Ordinary Shares held in Treasury) as at the Latest Practicable Date). To avoid a situation arising whereby the Company fully utilises its authority to buy back Ordinary Shares pursuant to the DCM prior to the 2026 AGM, the Board believes that it is in the best interests of the Company and its Shareholders for the Company’s buyback authority to be renewed prior to the 2026 AGM. If the buyback authority is not renewed, the Directors may not have sufficient authority to continue to buy back Ordinary Shares.

Over the last 3 years, share prices of investment trusts in the AIC Global sector have continued to trade, on average, at discounts to their NAV per share. However, as the graph below shows, the Company’s DCM has been successful in providing support to the Company’s share price (with the Company’s discount to NAV being much narrower relative to the average discount amongst other investment trusts in the sector) and so has been beneficial to Shareholders.

3. The General Meeting

Part 3 of this document contains a notice convening the General Meeting at which Shareholders will be asked to consider and, if thought fit, approve the Proposal. The General Meeting is to be held at 10.00 a.m. on 13 August 2026 at the offices of Juniper Partners Limited, 28 Walker Street, Edinburgh EH3 7HR. The Resolution being proposed at the General Meeting is being proposed as a special resolution and will therefore require that not less than 75 per cent. of the votes cast in person or by proxy are voted in favour of it in order to be passed.

All Shareholders are entitled to attend and vote at the General Meeting. The vote shall be taken on a poll. In accordance with the Company's Articles of Association, all Shareholders entitled to vote and present in person, by proxy or by corporate representative at the General Meeting upon a poll shall have one vote in respect of every Ordinary Share held or represented by them.

4. Action to be taken

Shareholders will find enclosed a Form of Proxy for use in connection with the General Meeting. Whether or not Shareholders propose to attend the General Meeting, they are requested to complete, sign and return the Form of Proxy, in accordance with the instructions printed on it, or submit a proxy appointment online as soon as possible.

To be valid, the enclosed Form of Proxy must be lodged online at www.eproxyappointment.com or submitted with the Registrar at The Pavilions, Bridgewater Road, Bristol BS99 6ZY as soon as possible and, in any event, so as to be received by not later than 10.00 a.m. on 11 August 2026.

The completion and return or online submission of the Form of Proxy will not prevent a Shareholder from attending and voting in person at the General Meeting. If a Shareholder does not hold their Shares directly, they are requested to arrange for their nominee to vote on their behalf.

5. Recommendation

The Directors consider the passing of the Resolution to be in the best interests of the Company and its Shareholders as a whole. Accordingly, the Directors unanimously recommend that Shareholders vote in favour of the Resolution.

The Directors intend to vote in favour of the Resolution in respect of their own beneficial holdings of Shares (amounting to 175,990 Shares, representing approximately 0.6 per cent. of the issued share capital of the Company (excluding Ordinary Shares held in Treasury) as at the Latest Practicable Date).

SPECIAL RESOLUTION

1. THAT, in substitution for any existing authority but without prejudice to the exercise of any such authority prior to the passing of this resolution, the Company be and is hereby generally and unconditionally authorised, for the purposes of section 701 of the Companies Act 2006 (the “**Act**”), to make market purchases (within the meaning of section 693(4) of the Act) of its Ordinary Shares of 5 pence each (“**Ordinary Shares**”) on such terms and in such manner as the directors of the Company may from time to time determine provided that:
 - (i) the maximum aggregate number of Ordinary Shares hereby authorised to be purchased shall be 4,087,601 or, if less, the number being 14.99 per cent. of the issued Ordinary Share capital of the Company (excluding Ordinary Shares held in Treasury) immediately prior to the passing of this resolution;
 - (ii) the maximum price (exclusive of expenses) which may be paid for an Ordinary Share purchased pursuant to this authority shall be the higher of:
 - a. 5 per cent. above the average middle market quotations for an Ordinary Share as derived from the London Stock Exchange Daily Official List for the five business days immediately preceding the day on which the purchase is made; and
 - b. the higher of the price of the last independent trade of an Ordinary Share and the highest current independent bid for such a share on the London Stock Exchange at the time the purchase is carried out;
 - (iii) the minimum price (exclusive of expenses) which may be paid for an Ordinary Share purchased pursuant to this authority shall be 5 pence;

2. A Form of Proxy for use by shareholders is enclosed with this document. To be valid, the Form of Proxy must be submitted, together with any power of attorney or other authority under which it is signed or a notarially certified copy of such power or authority (or a copy certified in some other way approved by the directors of the Company), at the address stated thereon so as to be received by the Company's Registrar, Computershare Investor Services PLC ("**Computershare**"), at The Pavilions, Bridgewater Road, Bristol BS99 6ZY or submitted at www.eproxyappointment.com no later than 48 hours (excluding any part of a day that is not a working day) before the time appointed for holding the meeting (or, in the case of an adjourned meeting, the adjourned meeting).
3. If a member wishes to appoint more than one proxy and therefore requires additional Forms of Proxy, the member should contact the Company's Registrar, Computershare, at The Pavilions, Bridgewater Road, Bristol BS13 8AE (Tel.: +44 (0)370 707 1186). Please indicate the proxy holder's name and the number of Ordinary Shares in relation to which they are authorised to act as your proxy (which, in aggregate, should not exceed the number of Ordinary Shares in the Company held by you). Please also indicate if the proxy instruction is one of multiple instructions being given. If possible, all Forms of Proxy should be returned together in the same envelope. If you submit more than one valid proxy appointment in respect of the same Ordinary Share for the purposes of the General Meeting, the appointment last delivered or received shall prevail in conferring authority on the person named in it to attend the General Meeting and speak and vote. If the Company is unable to determine which appointment was last validly received, none of them shall be treated as valid in respect of the relevant Ordinary Share(s).
4. In accordance with Regulation 41 of the Uncertificated Securities Regulations 2001, to have the right to attend, speak and vote at the meeting a member must first have his or her name entered in the Company's register of members (the "**Register of Members**") by not later than 6.00 p.m. on 11 August 2026 (or, if the meeting is adjourned, 6.00 p.m. on the day which is 48 hours prior to the time appointed for the holding of the adjourned meeting (excluding any part of a day that is not a working day)). Changes to entries on the Register of Members after that time shall be disregarded in determining the rights of any member to vote at the meeting referred to above.
5. CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so by using the procedures described in the CREST Manual and by logging on to the website www.euroclear.com. CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s), should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.
6. In order for a proxy appointment or instruction made using the CREST service to be valid, the appropriate CREST message (a "**CREST Proxy Instruction**") must be properly authenticated in accordance with Euroclear UK & International Limited's specifications, and must contain the information required for such instruction, as described in the CREST Manual. The message, regardless of whether it constitutes the appointment of a proxy or is an amendment to the instruction given to a previously appointed proxy must, in order to be valid, be transmitted so as to be received by the Company's Registrar (ID 3RA50) no later than 48 hours before the meeting (or in the event the meeting is adjourned no later than 48 hours (excluding any part of a day that is not a working day) before the time of the adjourned meeting). For this purpose, the time of receipt will be taken to be the time (as determined by the timestamp applied to the message by the CREST Application Host) from which the Company's Registrar is able to retrieve the message by enquiry to CREST in the manner prescribed by CREST. After this time any change of instructions to proxies appointed through CREST should be communicated to the appointee through other means.
7. CREST members and, where applicable, their CREST sponsors, or voting service providers should note that Euroclear UK & International Limited does not make available special procedures in CREST for any particular message. Normal system timings and limitations will, therefore, apply in relation to the input of CREST Proxy Instructions. It is the responsibility of the CREST member concerned to take (or, if the CREST member is a CREST personal member, or sponsored member, or has appointed a voting service provider(s), to procure that his or her CREST sponsor or voting service provider(s) take(s)) such action as shall be necessary to ensure that a message is transmitted by means of the CREST system by any particular time. In this connection, CREST members and, where applicable, their CREST sponsors or voting system provider(s) are referred, in particular, to those sections of the CREST Manual concerning practical limitations of the CREST system and timings.

8. The Company may treat as invalid a CREST Proxy Instruction in the circumstances set out in Regulation 35(5)(a) of the Uncertificated Securities Regulations 2001.
9. In the case of joint holders, where more than one of the joint holders completes a proxy appointment, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Register of Members in respect of the joint holding (the first-named being the more senior).
10. Any corporation which is a shareholder can appoint one or more corporate representatives who may exercise on its behalf all of its powers as a shareholder provided that they do not do so in relation to the same Ordinary Shares.
11. The right to appoint a proxy does not apply to persons whose Ordinary Shares are held on their behalf by another person and who have been nominated to receive communications from the Company in accordance with section 146 of the Companies Act 2006 ("**Nominated Persons**"). Nominated Persons may, under an agreement between them and the shareholder by whom they were nominated, have a right to be appointed (or to have someone else appointed) as a proxy for the General Meeting. If Nominated Persons do not have such a right, or do not wish to exercise it, they may have a right under such an agreement to give instructions to the person holding the Ordinary Shares as to the exercise of voting rights.
12. As at close of business on 15 July 2026 (being the Latest Practicable Date prior to publication of this document), the Company's issued share capital comprised 66,381,114 Ordinary Shares, of which 39,112,258 Ordinary Shares were held in Treasury. Each Ordinary Share carries the right to one vote at a General Meeting of the Company and therefore the total number of voting rights in the Company as at close of business on 15 July 2026 was 27,268,856.
13. Under section 319A of the Companies Act 2006 any member attending the General Meeting has the right to ask questions. The Company must answer any such question relating to the business being dealt with at the General Meeting but no such answer need be given if: (a) to do so would interfere unduly with the preparation for the General Meeting or involve the disclosure of confidential information; (b) the answer has already been given on a website in the form of an answer to a question; or (c) it is undesirable in the interests of the Company or the good order of the General Meeting that the question be answered.
14. Any person holding 3 per cent. or more of the total voting rights in the Company who appoints a person other than the Chairman as his/her proxy will need to ensure that both he/she and such third party complies with their respective disclosure obligations under the Disclosure Guidance and Transparency Rules.
15. You may not use any electronic address (within the meaning of section 333(4) of the Companies Act 2006) provided in this notice (or in any related documents including the Form of Proxy) to communicate with the Company for any purposes other than those expressly stated.
16. Under section 338 of the Companies Act 2006, Shareholders may require the Company to give, to members of the Company entitled to receive this notice of General Meeting, notice of a resolution which may properly be moved and is intended to be moved at the General Meeting. Under section 338A of the Companies Act 2006, members may request the Company to include in the business to be dealt with at the General Meeting any matter (other than a proposed resolution) which may properly be included in the business.
